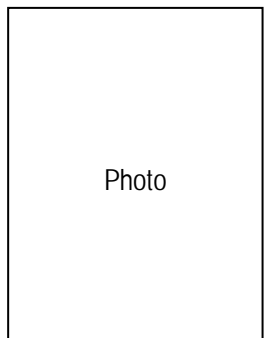

TERMS AND CONDITIONS

- 1) On submission of this application form, the applicant should pay a non-refundable application fee of HK\$1,000 or US\$135. Make check payable to AMERICAN INTERNATIONAL SCHOOL.
- 2)
 - (a) The school fees due are as stated in the American International School Fees Schedule.
 - (b) School fees are charged on an annual basis but are payable quarterly on August 1st, November 1st, February 1st and May 1st of each school year.
 - (c) In the case of late admission, the annual school fee to be paid shall be pro-rated according to the number of months remaining in the school year. For this purpose, a student enrolling before the 15th day of a given month shall pay the month's full fee, while a student enrolling after the 15th day a given month shall pay half of the month's fee.
 - (d) In the case of withdrawal by a student at any time during a school year, request for pro-rated tuition fee reimbursement must be submitted in writing, signed by a parent or legal guardian, and submitted to the School Office at least three months in advance to the withdrawal date.
- 3) The school year includes, but is not limited to, 180 days of instruction. School hours and school holidays are published by the school.
- 4) The school has the right not to accept or to cancel a student registration for: Serious misconduct, being deemed to be a corrupting or bad influence on other students, not achieving the requisite scholastic grade standard, and/or failing to pay school fees on time. In the case of expulsion of a student by the school for any reason whatsoever, there shall no refund of any school fees paid.
